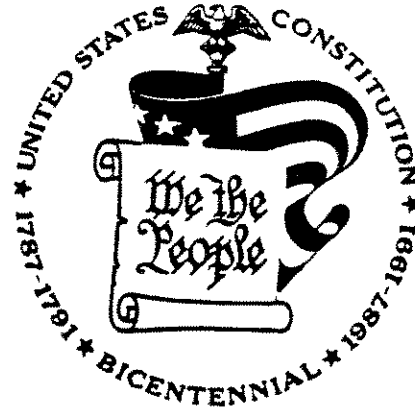
Applicants, wives and guests are invited and encouraged to attend.

### REPORT ON OUR CHAPTER'S BY-LAWS



hen the San Fernando Valley Chapter, S.A.R. was established in 1981, we asked for assistance in handling some of the details that we were unfamiliar with. Among these "details" were the required By-laws. The two Compatriots that prepared our By-laws patterned them after the 1976 State By-Laws. It seemed like a reasonable thing to do at the time.

Since that time, we have found that our By-laws do not provide all the guidelines we need and above all, are far too restrictive, particularly on matters relating to quorums and voting.

Our present By-Laws require a three-fourths membership approval of any By-law changes, and all of the required 3/4 of our membership must be present to vote on the changes at the meeting. A third of our membership resides too far away to reasonably be expected to participate in ANY MEETING.

The result is that we could not change or modify the By-laws and that restriction has impacted some of the activities of the Chapter.

Our By-laws are also at odds with certain MAJOR provisions of the newly approved California Society, S.A.R. By-laws. We must conform to the State's By-laws, which comply with our Articles of Incorporation, the National Society, S.A.R.'s By-laws and the State of California's Corporations Code.

The Chapter found itself in the less than desirable position of being mandated to change its By-laws to conform with the States, and at the same time to be legally required to make the changes in compliance with our existing By-laws. A no win situation.

Our President, Roger E. Robertson, in his capacity of State Chancellor made a motion at the November 7th, 1987 State Board of Manager's meeting to declare the By-Laws of the San Fernando Valley Chapter, S.A.R. "null and void", thereby clearing the way for the Chapter to affect the necessary changes. The Motion was unanimously approved.

Work has already started on the Revisions and the proposed rewrite of our By-laws will appear in the December issue of this publication.

Of general interest to our readers, other Chapters within the State seem to have the same problem, hence the actions taken set a precedence, that will enable our brother chapters to correct similar By-law restrictions.

WORKING ALONGSIDE A SOVIET  
ESPIONAGE AGENT  
- OR -  
HISTORY IN THE MAKING, UNDETECTED

**I**n the early 1940's I worked in the same laboratory and office as did a Soviet espionage agent. When he was tried and convicted, about a decade later, I was not aware of it. Some years later during a chance meeting, another engineer from that prior time and place was surprised to learn I had not been interrogated, that I was unaware of what had happened.

A recent book now published in paperback, "THE FBI-KGB WAR" by Robert J. Lamphere, is a fascinating story, of history that happened close around me, to which I was oblivious. It makes me wonder how much similar history is happening around me, and around others, to which we are essentially oblivious.

Thinking of the objectives of the Sons of the American Revolution, which are declared to be Patriotic, Historical and Educational, and thinking of our pledge by which we "reaffirm our faith in the principles of liberty.....and solemnly pledge ourselves to defend them against every foe", the story and the book are most relevant. much has changed in the forty plus years since then; much has remained the same, or become worse. How is it worse? The recent book "BREAKING WITH MOSCOW", by Arkady N. Schevchenko, the highest ranking Soviet official ever to defect, tells us how.

In 1943 I was a young engineer working on the design, development and flight testing of radar for controlling gun-turrets in aircraft. At the time, radar and its applications were classified secrets. The laboratory and office were at the General Electric plant in Schenectady, New York. I was involved with flight testing at various military locations around the country, which took me away much of the time. In Schenectady a new engineer was hired by the name of Morton Sobell. Although my association with him was limited, I remember him well. He was somewhat distant, almost arrogant, and rather sloppy in appearance. Before I left that position, he had gone to work for Reeves Instrument Company on Long Island, a company working on other secret Navy and Air Force projects.

What did he do for the Soviets? He was part of a KGB espionage network, passing national defence secret information to them. How did that effect us? In July 1950 the Korean War began, a war that many people, including top military officers, believed China and the Soviet Union and Korea would not have undertaken had the Soviet Union not been in possession of a functional atomic bomb. Klaus Fuchs and Harry Gold confessed to stealing and passing to Soviet agents the central secrets and David Glassman to stealing and passing

to Soviet agents key development details. These had cut years off the research and development time for the Soviets.

Morton Sobell was part of a KGB network which forwarded these and other national defense secrets to the Soviets, in addition to whatever secret data they may have stolen themselves. The group included Rosenberg, Barr, Elitcher, Sobell and Perl, all of whom had simular backgrounds, all of whom graduated from CCNY, all of whom worked in areas having access to secret information. The entire organized effort included many more who stole, photographed, couriered, recruited or directed a complicated network of KGB agents.

How had I missed being interrogated by the FBI? I had long since left Schenectady, was working for the government on guided missile development programs, in Washington D.C. How had I missed the news of Sobell being tried in New York City and convicted, with the Rosenbergs? In the midst of these happenings, in 1950 and 1951, I was attending law school in the evenings. My wife contracted polio. After the contagious stage, she was moved, still in an iron lung, in a moving van, from the hospital in Washington to a hospital in Baltimore for the months of recovery. She came home the envy of the other patients, almost completely recovered, we thought. Then one evening, right after dinner, she had a heart attack, went back into the iron lung. A few weeks later she had another attack and did not survive. During this time period my attention was focused on home problems, not on the

news. Several years later when I learned what had happened to Sobell, it was old news, without much detail.

The book by Lamphere is facinating and exciting. It is the story from the eyes of a man in the center of the action who was moving up the ladder in the FBI. It tells of the World War II KGB activity revealed by a code clerk who defected in Canada, of a British KGB agent innocently sent by the British to be their liason man in the CIA, of two other British KGB agents of aristocratic backgrounds found working in the British embassy in Washington, of how because of these British KGB agents the Soviets knew the Allies planned to stop at the Elbe River, which gave them incentive to push rapidly to and past Berlin. It tells how the leak through the British could the Chinese troops in Korea with plans of the United Nations troops, accounting for the early Chinese successes.

It shows how the Soviets plan decades ahead to have agents when and where desired. For example the KGB had provided tuition for certain potential agents to attend prestigious schools and has recruited them years later for stealing technology. It tells how intricate the networks are, with few individuals knowing more than one contact, by cover name. It shows them stealing industrial as well as military secrets, to enhance Soviet technology on many fronts. It tells how Judith Coplon, a KGB agent in the Foreign Agents Registration section of the Department of Justice, was convicted but freed after many appeals and a surprise decision

by Judge Learned Hand. It tells how the Soviet Exhibition at the 1939 Worlds Fair in New York was used as a training ground for young Soviets who would later become KGB agents in America. It follows many of those who escaped the country and tells of their later lives, mostly in the Soviet Union.

After serving the FBI for fourteen years Lamphere transferred to the Veterans Administration, advancing in five years to Deputy Administrator. Leaving government employment he eventually retired as a Senior Vice President of one of the country's largest insurance companies. Having grown up in a small, tough, mining town in Idaho, he had come a long way. His writing reflects this varied background.

Why at this late date did he write the book? Not for the money nor from the need of prestige, but because he felt he had been had! The National Public Affairs Center for Television (NPACT) asked him for an interview, to be included in a documentary of the Rosenberg case. The producer, Alvin H. Goldstein, promised faithfully it would be an honest portrayal of the case; it would be impartial. However, Goldstein arranged his interviews (and facts) to take, as one reviewer said "an unmistakable stand that the Rosenbergs were given a raw deal." As Benjamin Stein wrote in the Wall Street Journal after an interview with Goldstein, it made the Rosenbergs "not only innocent but heroic." According to Stein, Goldstein told him "Guilt or innocence of the charge is not the real issue. The real guts of the matter is that the Rosenbergs were being

tried for their political views." It mattered not to him that they were espionage agents feeding our technology to the Soviets. Being a KGB espionage agent, according to this producer for Public Television, was simply having different "political views." Does this sound like KGB disinformation?

Lamphere's interview had been chopped beyond recognition. The most important parts were missing. What remained were mere denials rather than explanations of the facts. He became irked that the public's money had been used to produce this misleading picture, irked more when the text was released as a book, and again when Goldstein and Public Television released an "update" a few years later.

"In this continued manipulation of American public opinion twenty-five years after the death of the Rosenbergs, I read the ultimate triumph of the KGB in the case. The enemy had managed to insert into the memories of a new generation of Americans a lie in the place of truth." So saith Lamphere.

His anger at the film's inaccuracies, mixed with a determination to set the record straight, became the genesis of the book. The book provides understanding of how the KGB disinformation permeates our media. It provides an inkling to history happening around us to which we should not be oblivious. It is historical information we need to understand in order to properly carry out our objectives and our pledge to the SAR. Besides all that, it is exciting and entertaining reading.

OLD BUSINESS

1. MINUTES OF THE AUGUST 31th MEETING

IT WAS MOVED by Compatriot Walter Walley and SECONDED by Compatriot George A. Eckert, Jr. that the Minutes of the August 31st Meeting be approved as amended. THE MOTION CARRIED.

2. TREASURERS REPORT

In the absence of Treasurer Charles M. Pitchford, Vice-President D.F. "Bill" Semerau reported on the Chapter's finances. The Chapter is in excellant shape and our permanent fund is growing. All indebtedness has been taken care of. Compatriot Semerau has invested \$2,500.00 in a Home Savings Custom Term Account for 90 days at a 6.3% interest rate which will yield 6.5% annually.

3. REPORT ON THE VALLEY COMPATRIOT

Compatriot Donald Norman Moran reported that he is very late with the September issue of the VALLEY COMPATRIOT and will have to combine it with the October issue to catch up.

It is hoped that once the correction in scheduling has been made that the publication will again be on time. He further reported that he has at hand the articles required to fill the November and December issues. He asked that any members that would like to submit articles for inclusion would be deeply appreciated. Several inquiries have been made seeking more of "Our Revolutionary War Ancestors" articles, so if you have a documented Revolutionary War ancestor, please send the details.

NEW BUSINESS

4. REPORT ON THE NOVEMBER 6TH, STATE MEETING

Secretary Donald Norman Moran advised that all has been prepared for a splendid Fall Meeting. The new By-Laws will be voted upon by a Special Meeting of the Membership. Compatriot Moran, as State President will be unable to represent the Chapter, and when the By-Laws are approved, Compatriot Robertson, our Chapter President, will, as State Chancellor, be a voting member of the Board of Managers by being Chancellor, therefore, the Chapter must send two (2) additional members.

5. REPORT ON THE CHAPTER BY-LAWS

Secretary Donald Norman Moran reported on that work on the new Chapter By-Laws will start when the State By-Laws are voted in. Our Chapter's By-Laws MUST be in compliance with the State By-Laws, which are governed by our Articles of Incorporation and the State of California's Corporations Code. It is a matter of Law that this be done. Additionally, over the past few years it has been found that our existing By-Laws have several short-comings. The major impediment is the 3/4's membership voting requirement on By-Laws changes. When the present By-Laws were written, no one envisioned that more than a third of our membership would reside outside California. This requirement can be overcome by the State Board of Managers declaring the By-Laws of the San Fernando Valley Chapter "Invalid" because of non-compliance.

6. REPORT ON THE EAGLE SCOUT PROGRAM

Vice-President Bill Semerau advised that he is in contact with the local Boy Scout Council and we will be receiving applicants for the Eagle Scout Scholarship program. There are well over one hundred (100) Scouts that receive the Eagle Scout Award annually in the Valley Area. Additionally, Secretary Moran has given the Eagle Scout Program literature to some Scouters in the Antelope Valley who have expressed interest in the program.

7. RESOLUTION ON THE S.A.R. 'S WAR SERVICE MEDAL

Secretary Donald Norman Moran proposed a resolution on reforming the requirements for the S.A.R.'s War Service Medal. Background: The Medal is presently given to any member of the S.A.R. who saw Federal Military service during those periods of time designated as "War Time" by the Congress of the United States.

NEW BUSINESS CONTINUED

7. RESOLUTION ON THE S.A.R.'S WAR SERVICE MEDAL, CONTINUED

In addition to the medal, a clasp, denoting which war, (i.e. WWI, WWII, Korea, Vietnam) is added to the ribbon drape of the medal.

Compatriot Moran explained that we have lost many men in the service of our Country during times that were not so designated and those men who have volunteered to serve their Country should not be excluded. To correct this injustice, he proposed that the War Service medal be presented to any member who served in the Armed Forces, and the Clasps be presented only to those who have been awarded a Campaign ribbon by the Federal Government. This would truly be recognizing the contributions of our men in uniform, and would be honoring those who actually served in combat areas.

THE MOTION was MOVED by Compatriot Walter Walley and SECONDED by Compatriot George A. Eckert. THE MOTION CARRIED.

8. RESOLUTION ON YOUTH MEMBERSHIP

Compatriot Donald Norman Moran introduced a Resolution calling for the National Society to establish a youth membership program that will enable members to place into membership any male at any age. THE MOTION WAS MOVED by Compatriot Bill Semerau and SECONDED by Compatriot Walter Walley. THE MOTION CARRIED.

6. LIVESTEAMERS HANDICAPPED MEET

Vice-President Bill Semerau passed out "flyers" on the annual BILL WEBB MEMORIAL HANDICAPPED MEET of the Los Angeles Live Steamers and the San Fernando Valley 4-H clubs. 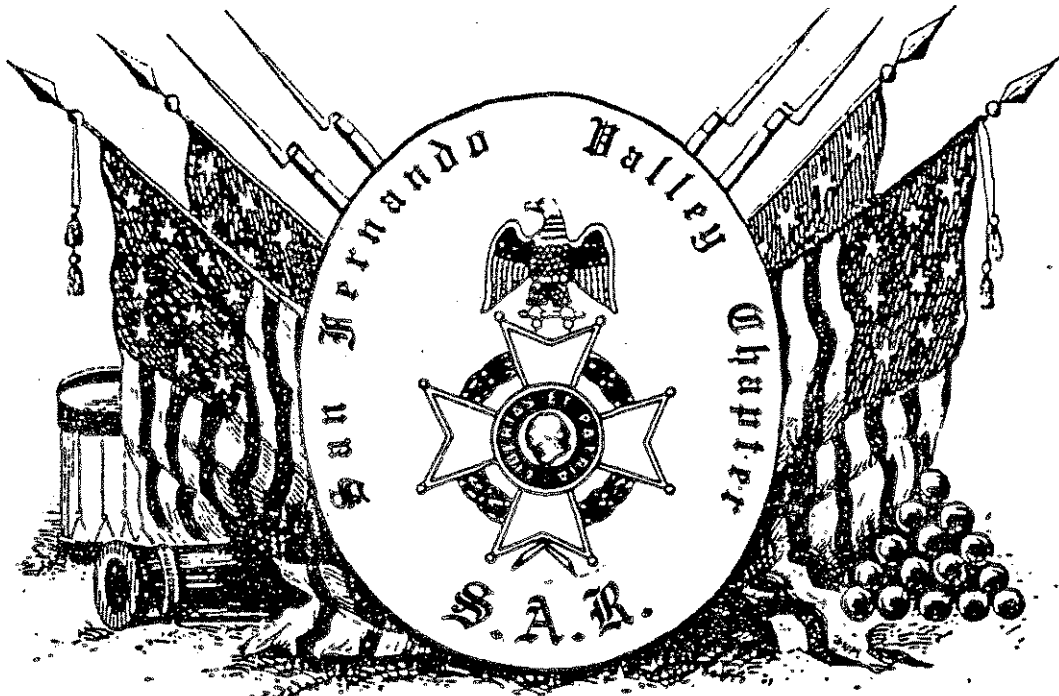

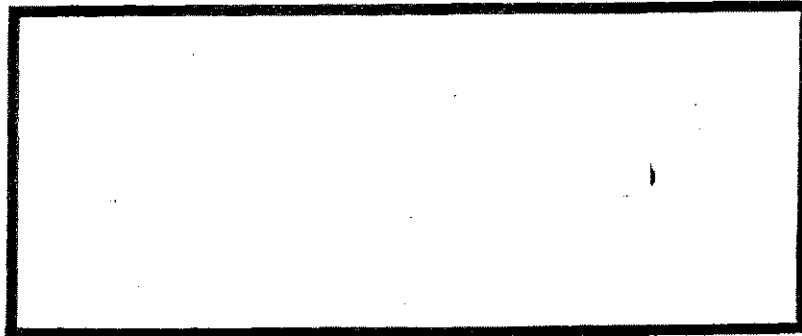
