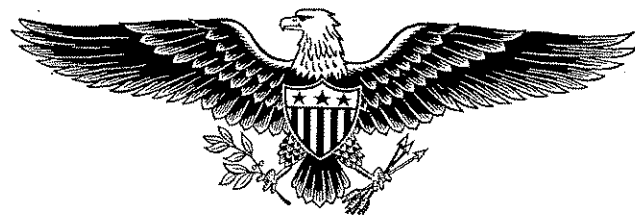

A THOUGHT TO PONDER - An Editorial

At the November 5th your editor took the podium during the discussions regarding law enforcement and education. He presented the following speech, repeated herein by request.

"A FENCE OR AN AMBULANCE"

"T'was a dangerous cliff, as they freely confessed
Thought to walk near its crest was so pleasant;
But over its terrible edge there had slipped
a duke and full many a peasant
So the people said something would have to be done,
But their projects did not all tally;
Some said, "Put a fence around the edge of the cliff"
Some, "An ambulance down in the valley."

But the cry for the ambulance carried the day;
For it spread through the neighboring city;
A fence may be useful or not, it is true,

For those who slipped over that dangerous cliff;
And the dwellers in highway and alley
Gave pounds or gave pence, not to put up a fence,
But an ambulance down in the valley.

"For the cliff is all right, if you're careful," they said,

It isn't the slipping that hurts them so much,
As the shock down below when they're stopping."
So day after day, as these mishaps occurred,
Quick forth would these rescuers sally
To pick up the victims who fell off the cliff,
With their ambulance down in the valley,

Then an old sage remarked: "It's a marvel to me
That people give far more attention
To repairing results than to stopping the cause,
When they'd much better aim at prevention.
Let us stop at its source all this mischief," cried he,
"Come, neighbors and friends, let us rally;
If the cliff we will fence we might almost dispense
With the ambulance down in the valley,"

"Oh he's a fanatic," the others rejoined,
"Dispense with the ambulance? Never!
He'd dispense will all charities, too, if he could;
No! No! We'll support them forever.
Aren't we picking up folks just as fast as they fall?
And shall this man dictate to us? Shall he?
Why should people of sense stop to put up a fence,
While the ambulance works in the valley?"

But a sensible few, who are practical too,

They believed that prevention is better than cure,
And their party will soon be the stronger.

I submit that this poem sums up the current fuzzy thinking of our law makers toward our current crime ridden Country. An "Ambulance" in the valley is not now the answer, nor will it ever be! For us, the members of the Sons of the American Revolution to expend our limited resources to acquire another ambulance is ludicrous. The answer to this problem was addressed when the SAR was Chartered in 1906. Its our constitution's stated goals and objectives - Historical, Educational and Patriotic - that is the proverbial "fence".

Today's students are being taught revisionist history. They are taught from the earliest elementary school grades about the repression of minorities. They are taught every possible negative that can be found or invented. The many positive in our history are ignored. The minority students learn they are repressed by the majority - - they are taught they are without hope. The majority students learn to be ashamed of their heritage and are made to feel guilty for the alleged sins of their fathers.

The education community has replaced God with monkeys. The Government has replaced the Ten Commandments with an estimated 55,000,000 laws nationwide. The result: Two generations of Americans who have no historical personalities to emulate. No national heroes. No role models worthy of being such. No pride in Country - No patriotism, or understanding of it, and little sense of personal responsibility.

Our founding fathers, who risked everything for the sake of national liberty and freedom, the George Washingtons, the Ben Franklins, the Tom Jeffersons, the Abraham Lincolns, the Teddy Roosevelts, of our history are being ignored or replaced by contemporary celebrities. In recent years, these current "heroes" include Mike Tyson, convicted rapist, O.J. Simpson, accused of double homicide,





Michael Jackson, accused of child molestation, Madonna, who has added a whole new dimension to the term immorality. These are the examples our young people look up to, and you wonder why we have a problem?

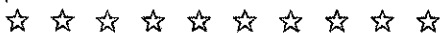
With our limited resources we are told we are without any influence. Our total membership constitutes .001 per cent of the population. But, we can have some impact. Like a tiny, sharp needle, when pressed against the right spot it will be felt and not ignored.

I believe that we should direct our available resources into convincing all patriotic societies to join a coalition to force the educational community into returning to teaching history, not social studies, not the politically correct revisionist history, but the true history of our great nation, with all of its achievements and all its unblemished heroes.

If the schools revert back to using the material we were educated with - the material that gave us a sense of Nationalism and Patriotism - that educational material that provided our generation with true and great role models. CHAPTER FINANCIAL REPORT AND 1995 BUDGET REPORT OF THE TREASURER.

January 1st, 1994 to November 18th, 1994

EXPLANATION OF THE 1995 BUDGET

During 1994 our Chapter's revenues (donations) fell below anticipated levels. On four occasions we were impacted by cash flow problems. To prevent that from reoccurring, the 1995 budget is much more severe, actually impacting some of our program. At the November 19th Meeting of the Chapter The following "cuts" were requested and as regrettable as they are , were approved.

- Our mailing list will be scrutinized to insure there are no unnecessary entries.
- We will no longer be sending copies of the SAR Magazine, California Compatriot, back issues of the Valley Compatriot to applicants. We will rely solely on the "SAR Wants You". This action will reduce our printing and mailing costs by 25%.
- Applicants will no longer be automatically placed on our mailing list, until such time as we receive a response from the.
- Mailings to our Chapter offers will be eliminated, and copies of all Chapter reports and correspondence will be hand delivered at our monthly meetings.
- It has been a Chapter tradition to award the SAR's War Service Medal to all new members so entitled. The cost to the Chapter is \$19.00 each which consumes the majority of the Chapter's portion of the admissions fee. The Medal will still be made available through our Chapter's Secretary, but only on a reimbursable basis.

It is hoped that increased donations and the above reductions in our budget will make our Chapter more solvent. If donations return to pre-1994 levels we can reinstate some of these programs.

THE MINUTES OF NOVEMBER 19th, 1994 MEETING

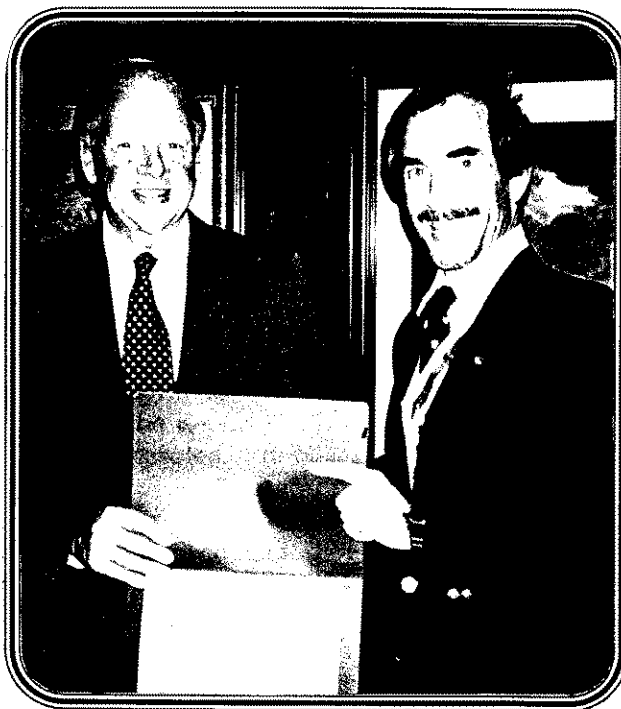

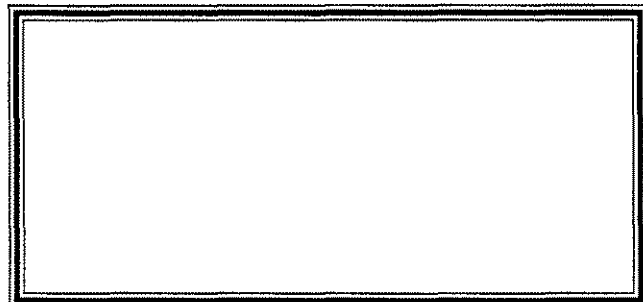
