




CAPTAIN DAVID HITCHCOCK

Who served the cause of American Independence as a Capain in the Connecticut Militia at the time of the Lexington Alarm. He was later transferred to the Continental Line and concluded his

service in that capacity.

Who served the cause of American independence as a mounted riflemen in Colonel Davy's Rowan County, North Carolina Regiment of Horse.


PATRIOT HENRY RICE

Compatriot's George Sutherland Van Dorn and Donald Moran accepted the award at the Congress from President General Stewart B. McCarty.


This is the third time our Chapter has been so honored.


The first was "Our American Heritage" and the second was a tribute to our World War II veterans, entitled

Report on Our R.O.J.C. Awards Frogram

On July 13th, 1995, the following report was delivered by LtC Edgar Duer Whitley to the members of the San Fernando Valley Chapter present at its monthly meeting.

This is the final report on the actions completed pertaining to the R.O.T.C. Units in High Schools and Universities in the Los Angeles areaon behalf of the SAR for 1995.

There were twenty-one High Schools R.O.T.C. Units and five University R.O.T.C. Several of the award recipients named on the previous page have responded with letters of appreciation indicating how proud they are to have received the SAR medal and how they will feel honored to wear the ribbon associated with the medal on their uniform. They thank the SAR for acknowledging their efforts and work towards successful achievement.

Considering the cost of this program to the Chapter which is less

than \$250.00 for the medals and certificates and realizing postal costs of less than \$75.00 are born by the undersigned and therefore not a burden to the Chapter, it is concluded this R.O.T.C. program should be continued next year.

Increased Chapter participation is needed at the individual awards ceremonies where the medals are presented. It enhances the award when a member of the organization presenting the medal is present.

Special recognition is should be granted to Compatriot Dr. Clifford J. Craft for his adding a monetary gift of \$25.00 to the SAR honoree at each of the two ceremonies he attended.

Our new member, Compatriot Kenneth Woods attended three award functions and a letter from the Cadet Commander of the Crenshaw High School Junior R.O.T.C. applauded Ken's contribution to the ceremony.

The R.O.T.G. Receives Much Aceded Policital Support

Over the years we have seen increased academic resistance to the R.O.T.C. program. Since it is almost entirely funded by the Department of Defense, it is hard to understand why the school leaders want to drop the program. It can not be justified as a budgetary issue.

The academic record of the R.O.T.C. is almost unbelievable in today's environment. We understand that 97% of all High School R.O.T.C. students graduate, compared to a Los Angeles School District average of 60% of other students. The number that continue their education by going on to college is also astonishing. Over 80%. In every way the R.O.T.C. program has proven its great value to American Society. Yet it is always under attack in the academinic world.

Could it be that those in control of our educational institution dislike having a working example that their theories do not work. The positive example that the R.O.T.C. program sets through its use of discipline and an orderly environment versus the "if it feels good - do it" attitude of the academic worlds which results in anarchy and/or anti-government thinking. The academic community wants the R.O.T.C. off campus!

In early August, 1995, Governor Pete Wilson signed into law AB415. This bill was designed to stop California State University presidents from kicking R.O.T.C. programs off their campus.

The legislation introduced by Assemblyman William J. "Pete" Knight, Republican from Palmdale, was initiated to stop this injustice. The San Fernando Valley Chapter, had submitted numerous letters to Assemblyman Knight supporting this action.

In recent years, several California State University presidents have removed the R.O.T.C. program off their campuses, using as an excuse the federal military policy on homosexuals violates state laws banning such discrimination.

Pete Knight's bill stated that there is nothing in the state law that allows a University president to remove an R.O.T.C. program, or for that matter establish one.

Mr. Josh Lowery, an aide to Pete Knight said that if University presidents fail to act in "good faith" by leaving the R.O.T.C. programs alone, Assemblyman Knight will introduce even stronger measures in January 1996.

When the original, strongly worded bill was introduced the Assembly was evenly divided between Democrats and Republicans. In order to obtain the votes needed for passage, the language had to be softened.

Pete Knight, a former Air Force testpilot, is noted for his blunt matter of fact style. He stated" It is not the place of a state university president to use his office as a bully pulpit to further a personal agenda. The R.O.T.C. produces more than outstanding men and women officers for our military, it produces outstanding citizens for our Country."


This legislation will send a signal through the academic community to leave the R.O.T.C. alone.



The original parchment was for the 359 acres sold to Edward Duffield for the sum of 19 pounds. Thirteen years later, Mr. Duffield sold 197 acres of this homestead to Daniel Moore. Daniel Moore and his two brothers, along with his eleven children, had emigrated from Scotland and soon owned a total of 3,000 acres in the valley they named

Scott's Valley because it reminded them of their homeland.

Don returned to California with the parchment document and, showing it to a document restoration company that had a booth at the Genealogical Jamboree, decided to have the document restored and mounted. After several weeks, the document was returned beautifully restored through and advanced chemical process and mounted in an air-tight container which was

framed. This document, measuring about 16 inches across and 14 inches high, looked much as it must have shortly after it was written, one side with beautiful colonial calligraphy and the reverse with the Penn seal.

THE CHAPTER'S COLOR GUARD.



"Ken could fly any d__m flag he wanted, any d__m time he wanted,any d__m place he wished."


The flag display went back up.

Father George A. Burns for Chaplain General


